9. PUBLIC COMMENTS

Edin Enamorado congratulated Council Lomeli on the land acknowledgment, stated there is a lot of misinformation whether this was Tongva or Kizh land, commented on street vendors mentioned how hard it is for them to obtain permits and hopes the city can follow with LA County Board of Supervisors, asked Council whether the City still has containers in the parks for emergency food supplies when there are earthquakes, also commented on the Prima Development and his concerns of conflict of interest.

<u>Susie</u> commented on the KIPP project, reminded Council that Cudahy Alliance for Justice won the litigation where KIPP is required to do a legal binding clean-up, mentioned they need Council's support to ensure the clean-up is done with oversight of DTSC, also commented on previous speaker Edin Enamorando comments and to look into any conflict of interest. Also stated Cudahy Youth Foundation is applying for the permit and sale of firework stand and requested a fee waiver and their support.
